TOWN OF SHARPSBURG MINUTES OF THE TOWN COUNCIL MEETING

June 4, 2012

A regular scheduled meeting and a called Public Hearing of the Sharpsburg Town Council was held Monday, June 4, 2012, at 7:00pm, in the Town of Sharpsburg at the Sharpsburg Recreation Center.

Mayor Staley presented a bid to construct a side entrance porch over the double doors coming into the recreation center. Council Member Davenport motion to accept the Cochran Construction bid, Council Member Anderson seconded. Motion carried, unanimously.

Mayor Staley called for a motion to accept the GMA Deferred Compensation Plan update. Council Member Anderson to accept, Council Member Davenport seconded. Motion carried, unanimously.
